Use of technology provides great educational benefits to students. It is a general policy that the computers, network, Internet, and other tools of technology are to be used in a responsible, efficient, ethical and legal manner in accordance with the mission statement of the West Fork Schools.

Access to the Internet is given as a privilege to students who agree to act in a considerate and responsible manner. Unfortunately, some material accessible via the Internet may contain items that are illegal, defamatory, or potentially offensive to some people. The school requires students and parents or guardians read, accept, and sign the following rules for acceptable use of tools of technology and on-line behavior.

Students are responsible for good behavior on the Internet just as they are in school. General school rules for behavior and communication apply.

Network storage areas may be treated like lockers. Network administrators may review files and communications to maintain system integrity and ensure users are using the system responsibly. Users should not expect files would always be private.

The following are not permitted:

- Using any other e-mail system (for example Hotmail, Yahoo, etc.) other than the school's system
- Sending or displaying offensive messages or pictures.
- Using obscene language
- Harassing, insulting or attacking others
- Damaging computers, software, computer systems, networks or other devices
- Violating copyright laws
- Using another's password
- Trespassing in another's folders, files or work
- Using the network for non-school related activities
- Revealing the personal address or phone number of yourself or any other person without permission from your instructor
- Using activities or games that do not support the standards and benchmarks of the school district

Violations may include but are not limited to those stated above. Consequences for violations will be determined by the teacher involved and/or administration, which may result in the loss of computer or Internet privileges.
